Having trouble finding the time to see the doctor for your recommended screenings? Do you wish you could get screenings on your own schedule, in the comfort of your home? If so, we have an easy way for you to get the tests you need! We will soon be mailing you three kits in the mail: an A1c blood test kit, a urine test kit and a colorectal test kit.

As you know, early detection is crucial to staying healthy. The blood test kit checks your A1c level. The urine test kit detects small levels of albumin (protein) in your urine and checks the health of your kidneys. The colorectal test kit checks hidden blood in your stool and can help prevent or treat colorectal cancer in its early stages.

All three tests help your doctor evaluate any treatment you might need. The screenings are part of your coverage and there is no charge. To process the screenings, we've partnered with Home Access Health Corporation, an independent company that provides laboratory testing services.

The tests do not require fasting and you should continue taking any medications according to your normal schedule. Once you've received the kits:

1. Read and follow the detailed instructions.
2. Return the tests in the prepaid envelope as soon as possible.
